- Materials for the students to use. Not all students have bibles.
- Financial Support
- VPEAHM indepentantly spends 2000vt per day in transportation and other necessities when moving into schools.



Recommendation

- For the Religious education should not be taught as a normal subject but as a life embarking subject, because it determines also an individuals behaviour.
- All students should have a bible.
- The churches within the area of schools should interact. To fellowship with students and also school visitations regularly.



Recomendation

- To do Personal counseling with all staff and students in order to bring out a respectable manner in all.
- Each school should have a trained personal counselor to deal with problems within individuals in the school.
