1.9.5 Frequency of non-compliant secondary schools, by province, education authority, language of instruction and criterion - 2018, 2019, 2020

Across all provinces, the most frequent non-compliant schools authority were recorded to be under the Private Authority with a range of 42% to 53% on all reported aspects and the highest non-compliance aspects was regarding the enrolment issue, then followed by the schools under the Church Government Assistance from 23 to 24% and the highest non-compliance aspects was regarding the financial issue. The least significant were schools under the Government of Vanuatu with a range of 20% to 30% and the highest non-compliance aspect was regarding the financial issue.
