## PRESS STATEMENT

#### PROGRESS ON TEACHERS' CLAIMS PAYMENTS

**Port Vila, Vanuatu – Wednesday 19 March 2025:** The Ministry of Education and Training (MoET) is working hard to progress payment of teachers' claims following the 2024 Vanuatu Teachers Union teachers' strike, following a rigorous verification process.

Of 4,812 claims submitted, MoET has verified 896 (18.6%) as proven legal claims. Of the substantiated claims, 529,601,817VT has already been paid across 591 claims, with 305 outstanding for completion. The remaining 3,916 have been confirmed as unsubstantiated. Further detail is provided in the attached tables.

Teachers with substantiated claims will receive payments directly to their personal accounts.

All future claims will be verified under MoET's normal process before they are listed as substantiated claims. Claims regarding the implementation of the new *Teaching Service Commission Staff Manual* (2024) are subject to the budget being appropriated before they can be reviewed.

Details on individual payments and claims are confidential. Individual queries should be directed to the Teaching Service Commission or MoET.
