## 21st PHES Consultation Meeting

The Vanuatu Ministry of Education with support from the UNESCO Office for the Pacific States will host the 21st Consultation Meeting of Pacific Heads of Education System (PHES) in Port Vila on the 20th and 21st of October, 2015.

The PHES Consultation Meeting provides the education permanent secretaries with a technical forum to discuss and deliberate on regional education initiatives and education issues important to the Pacific Island Countries and Territories as well as an agenda for the Forum Education Ministers' Meeting (FEdMM).

The FEdMM is organized by the Pacific Islands Forum Secretariat (PIFS)<sup>1</sup> every 12 to 18 months. It is the highest education forum among Pacific Island Countries and Territories and development partners to discuss policy issues facing regional and national education and strategies for implementing the Pacific Education Development Framework (PEDF).

The 20th PHES meeting was held in Tonga in October 2013 and it was attended by permanent secretaries of education systems from 11 Pacific Island Countries and Territories. It was also attended by representatives of education development partners. This meeting deliberated on the following themes

- Update on USP implemented projects REAP, policy and planning training, untrained teachers, OLPC, open schooling
- Report on literacy assessment and PaBER
- Report on the literacy conference in New Zealand
- Teachers code of ethics
- Introduction of the Pacific Early Age Readiness and Learning (PEARL)
- Update on (i) climate change and disaster risk management education and (ii) HIV and AIDS education (comprehensive sexuality education)
